**Amir and Shaheda Khan Scholarship for Law**  
**2012-2013 Information Sheet**

**PURPOSE:**

To provide annual scholarships for individuals of the Islamic faith who are pursuing a Juris Doctor (JD) degree at Case Western Reserve University (Cleveland, OH), Michigan State University (East Lansing, MI), The Ohio State University (Columbus, OH), University of Dayton (Dayton, OH), University of Michigan (Ann Arbor, MI), or The University of Toledo (Toledo, OH) who will be full-time (as defined by the institution) students during the 2012-2013 academic year. Scholarship recipients may re-apply in subsequent years. Applicants must be U.S. citizens.

**QUALIFICATIONS FOR ELIGIBILITY:**

1. The applicant must be a United States citizen with permanent residency status, and of the Islamic faith.
2. The applicant must currently be enrolled as a full-time student pursuing a Juris Doctor (JD) degree. Preference may be given, but not limited, to first year law students.
3. The applicant must be attending one of the following post-secondary institutions (in Ohio or Michigan): Case Western Reserve University, Michigan State University, The Ohio State University, University of Dayton, University of Michigan, or The University of Toledo.
4. The applicant must complete and submit the Amir and Shaheda Khan Scholarship for Law application form, including required attachments (see page two of the application form).
5. The applicant must submit an official copy of his/her most recent transcript.

**BASIS FOR SELECTION:**

Scholarship recipients will be nominated by the Toledo Community Foundation's Scholarship Advisory Committee and approved by the Foundation's Board of Trustees.

In assessing candidates for this scholarship, the Advisory Committee will take into consideration financial need and scholastic aptitude and academic achievement as demonstrated by the information submitted on the scholarship application form, required attachments and academic transcript.

**It is anticipated that one (1) \$1,000 scholarship will be awarded for the 2012-2013 academic year. Toledo Community Foundation will notify (via letter) the scholarship recipient(s) in early May 2012.**
