Ed and Sandra Metzger Scholarship 2012–2013 Information Sheet

Purpose:

To provide scholarship(s) for students pursuing an undergraduate degree at an accredited two or four-year post-secondary institution who meet the qualifications for eligibility noted below. Applicants must be U.S. citizens. It is anticipated that one \$500 scholarship will be awarded in spring 2012.

Scholarship recipients may re-apply for additional years of undergraduate study and will be considered for renewal if they maintain a cumulative 2.5 GPA and demonstrate progress toward their degree.

Qualifications for Eligibility:

Applicants must meet one or more of the following criteria:

- a) Graduating senior or graduate of a high school located in Wood County, OH;
- b) Intent to pursue an undergraduate degree in the field of manufacturing, engineering, interior design or business;
- c) Demonstrate average to above-average academic achievement; and
- d) Have need for financial assistance in order to pursue post-secondary education.

Priority will be given to applicants (meeting at least one or more of the criteria listed above) who are also the child, step-child, grandchild or step-grandchild of a BioFit Engineered Products employee. Currently BioFit Engineered Products is located at 15500 BioFit Way; Bowling Green, OH 43402.

Basis for Selection:

The Scholarship will be awarded on the basis of the information reported on the application form and related attachments.

How to apply:

1. Complete the scholarship application form (three pages).
2. Attach additional required application materials (see page three of the application form):
 - a. Listing of employment, community, extra curricular activities and awards
 - b. Official copy of your most recent transcript

The Toledo Community Foundation Scholarship Advisory Committee will nominate award recipient(s), with final approval by the Board of Trustees of Toledo Community Foundation. Awards will be announced in early May 2012. If, in the opinion of the Scholarship Advisory Committee members, there are no qualified recipients in a given year, no nomination will be made.
